By executing this agreement, and being 18 years of age or older, I understand that RHG will complete a criminal background check and my ability to volunteer for the organization is dependent upon successful completion of this review.

1. I understand that there are risks and dangers involved, including risks related to serving of concessions to patrons of the Facility, and I voluntarily assume all of those risks and dangers, including the risks and dangers of personal injury and/or property damage that may occur during or arise from participating in such activities; and,

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown of my participation in such activities, including risks related to serving of concessions to patrons of the Facility, EVEN IF ARISING FROM THE NEGLIGENCE OF Craft Culinary Concepts LLC, State Farm Stadium, the Arizona Tourism and Sports Authority D/B/A The Arizona Sports and Tourism Authority, Arizona Cardinals Football Club LLC, New Cardinals Stadium, LLC, ASM Global, Insignia Event Services, or others, and assume full responsibility for my participation; and,

I further hereby release and discharge Craft Culinary Concepts LLC, State Farm Stadium, the Arizona Tourism and Sports Authority D/B/A The Arizona Sports and Tourism Authority, Arizona Cardinals Football Club LLC, New Cardinals Stadium LLC, ASM Global, Insignia Event Services, and their affiliates and their respective owners, officers, employees, and agents (all of whom are referred to here collectively as “the Released Parties”) from all claims, actions, suits, proceedings, costs, expenses, damages, and liabilities, including attorney’s fees (“claims”), involving personal injury and/or property damage arising from, connected with, relating to, or resulting from my participation in such activities, from any activity performed by Sub-Contractor/Vendor or any member of the Sub-Contractor/Vendor in connection with such activities, and/or from my participation in any activities or presence at the Facility, including without limitation all claims arising from, connected with, relating to, or resulting from any actual or claimed negligent acts or omissions of any of the Released Parties, whether active or passive.

4. Arbitration: In further consideration of allowing me to participate in the aforementioned activities, all disputes, claims or controversies that exist or that may arise between me and any of the Released Parties, including without limitation any dispute arising out of or relating to the terms of this Agreement, and including without limitation all claims that any of the Released Parties engaged in conduct prohibited on any basis under any federal, state, or local statute, ordinance, regulation, rule of decision, or principle of common law, shall be referred for final, binding, and conclusive arbitration in the City of Phoenix, Arizona, administered by JAMS. I agree to arbitrate and process any and all such disputes, claims, or controversies in my individual capacity only; I hereby waive any and all rights that I may have to bring, participate in, or be a party to any action or arbitration against any of the Released Parties in any forum that is commenced or that proceeds on any class, collective, representative, or similar basis. Both parties have the right to be represented by counsel in any such arbitration. The arbitrator will have the exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, or formation of this Agreement, including without limitation any claim that all or any part of this Agreement (including without limitation this arbitration clause) is void or voidable. This Agreement does not constitute an agreement to arbitrate any disputes, claims, or controversies in any purported class, representative, or consolidated proceeding. The sole grounds on which the arbitration decision may be appealed are those set forth in the Federal Arbitration Act, 9 U.S.C. §10(a). The purpose of this provision is to ensure that any and all disputes that may arise shall be resolved through binding, conclusive arbitration as opposed to court or administrative litigation.

I understand that if I am over 18 years old, I will be involved in the sale of alcoholic beverages. In addition, I agree to maintain the highest standards in serving alcoholic beverages, follow CCC's policies and guidelines explicitly and to abide by all laws that govern alcoholic beverage sales.
